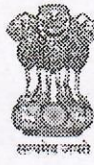


Accordingly the following transfer/posting is ordered in the cadre of SSO/O.S./Branch Manager Gr.II with immediate effect.
