NOTICE INVITING APPLICATIONS FOR EMPANELMENT OF ADVOCATES

Employees' State Insurance Corporation (ESIC), a statutory body under Ministry of Labour & Employment, Government of India, intends to empanel advocates for representing the Employees' State Insurance Corporation before Employees' Insurance Court, District and Subordinate Courts, Magistrate Court, District Consumer Forum and other tribunals or judicial forum in Salem, Tiruchirappalli, Krishnagiri and Thanjavur districts.

The practicing advocates who are registered with Bar Council of India / State Bar Council with minimum of 5 years of experience are eligible for empanelment. The qualification, experience, schedule of fees, other terms and conditions for empanelment have been prescribed in Annexure-A, and Annexure-B (Other Court(/s)/Tribunals), available on website www.srosalem.esic.gov.in.
